THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal") is seised of a "Lazarevic Defence Notice Regarding MFI Documents", filed on 25 February 2008 ("Notice"), and hereby issues this order thereon.

- 1. In the Notice, the Lazarević Defence provides a list of 19 exhibits, namely 5D227, 5D726, 5D773, 5D879, 5D883, 5D960, 5D963, 5D966, 5D1070, 5D1076, 5D1104, 5D1131, 5D1132, 5D1178, 5D1210, 5D1244, 5D1245, 5D1292, 5D1312, which have been marked for identification in the course of the trial, their admission into evidence being suspended until such time the English translations of the same became available. In the Notice, the Lazarević Defence informs the Trial Chamber that the English translations of these documents are now available and that they have been uploaded into the e-Court system. The Lazarević Defence also requests that these exhibits now be admitted into evidence.<sup>1</sup>
- 2. The Prosecution has not responded to this Notice.
- 3. The Chamber notes that the translation linked to exhibit 5D1312 is in fact another B/C/S original of that document. Accordingly, this exhibit will not be considered for admission into evidence until such time when its translation is available and uploaded into the e-Court system and the Chamber and parties are informed of this.
