TRIAL CHAMBER I ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

NOTING the "Decision on Request for Alteration of Conditions of Provisional Release", rendered on 8 May 2008 ("Decision"), whereby the Trial Chamber granted a modification of the conditions of the Accused's provisional release;

NOTING that the fourth paragraph of page 2 of the Decision reads, in relevant part, that "the Defence withdrew the request in relation to the period of July due to the scheduling of the Pre-Trial Conference on 21 July 2007 and the Opening Statement of the Prosecution on 24 July 2007;"

NOTING the "Order Scheduling Start of Trial", rendered on 8 May 2008, whereby the Trial Chamber ordered "the Pre-Trial Conference pursuant to Rule 73 *bis* to take place on 21 July 2008" and "the Opening Statement of the Prosecution pursuant to Rule 84 to take place on 24 July 2008";

CONSIDERING that there have been errors with respect to the dates mentioned in the aforementioned paragraph in the Decision;

HEREBY ORDERS that the fourth paragraph of page 2 of the Decision should read, in relevant part: "the Defence withdrew the request in relation to the period of July due to the scheduling of the Pre-Trial Conference on **21 July 2008** and the Opening Statement of the Prosecution on **24 July 2008**."
