THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the former Yugoslavia since 1991 ("Tribunal") is seised of the "Ojdanić Motion to Admit One

Document (3D1136) from the Bar Table," filed 8 May 2008 ("Motion"), and hereby renders this

order in relation thereto.

1. In the Motion, the Ojdanić Defence requests the admission into evidence of a conclusion of

the National Council for Cooperation of the Government of the Republic of Serbia to show that

another report from the Third Army, dated 4 June 1999, on a similar topic, was not logged into the

VJ General Staff/Supreme Command Staff logbook.

2. In its "Decision on Joint Ojdanić and Lukić Request to Call Živojin Aleksić and Dušan

Mladenovski," issued 3 April 2008, the Chamber granted leave for the document to be added to the

Ojdanić Rule 65 ter exhibit list.

3. The Prosecution does not object to the document being admitted into evidence, and the

Pavković Defence has indicated that it would support the document's admission into evidence.

4. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and

Evidence of the Tribunal, hereby GRANTS the Motion and ORDERS that exhibit 3D1136, along

with its translation, be admitted into evidence.
