THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the former Yugoslavia since 1991 ("Tribunal") is seised of "Sreten Lukic's Request Regarding

Exhibit 6D 885," "Sreten Lukic' Request Regarding Exhibit 6D 1350," and "Sreten Lukic's

Request Regarding Exhibit 6D 1360," all filed on 29 April 2008 ("Motions"), and hereby issues

this order thereon.

1. On 18 February 2008, exhibit 6D885, entitled "SUP Zrenjanin, Denunciation against Goran

Bulić for criminal act of robbery (technical equipment) (dated 2 September 1998), Judgment of

Higher Discipline court of MUP, Belgrade on appeal of the accused Goran Bulić," was marked for

identification pending translation. On 10 April 2008, exhibit 6D1350, entitled "Vucitrn

Department of the Interior - dispatch no. 36/2491/99 of 30 May 1999, sent to the Chief of Crime

Police Department in relation to Operation Pariz," was marked for identification pending

translation. On 17 April 2008, exhibit 6D1360, entitled "Sreten Lukić's work record book," was

marked for identification pending translation. The Lukić Defence informs the Chamber and the

parties that complete translations for exhibits 6D885, 6D1350, and 6D1360 are now available and

have been uploaded to eCourt. Further, the Lukić Defence requests that these exhibits and their

translations be admitted into evidence.

2. The Prosecution has indicated that it does not intend to respond to the Motion.

3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and

Evidence of the Tribunal, hereby GRANTS the Motions and ORDERS that exhibits 6D885,

6D1350, and 6D1360, along with their translations, shall be admitted into evidence.
