# **The Accused:**

**TRIAL CHAMBER III** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

**NOTING** the confidential Subpoena issued on 7 April 2008 to Ljubiša Petkvić ("Accused") for him to appear as a witness called by the Chamber pursuant to Rule 98 of the Rules of Procedure and Evidence of the Tribunal ("Subpoena" and "Rules", respectively);

**NOTING** the confidential Order in Lieu of an Indictment for Contempt issued by the Chamber on 13 May 2008, in which Ljubiša Petković ("Accused") is called to appear before the Chamber on 27 May 2008 in order to reply to the accusation of contempt of the Tribunal for having knowing and willingly interfered with the administration of justice by refusing to respect the Subpoena and appear as a witness called by the Chamber ("Order in Lieu of an Indictment");

**NOTING** the confidential Order to Arrest and Transfer issued by the Chamber on 13 May 2008 ("Arrest Warrant");

**CONSIDERING** that the Accused was transferred to the seat of the Tribunal on 28 May 2008;

**CONSIDERING** that the reasons for the confidentiality of the Subpoena, Order in Lieu of an Indictment and Arrest Warrant no longer exist and that the Chamber thus finds it in the interests of justice to lift their confidentiality;

#### FOR THE FOREGOING REASONS

**PURSUANT TO** Rule 54 of the Rules

**ORDERS** the Registry to lift the confidentiality of:

- (i) the Subpoena;
- (ii) the Order in Lieu of an Indictment;
