THE APPEALS CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Appeals Chamber” and “International Tribunal”, respectively),

NOTING the Judgement rendered in this case by Trial Chamber II on 31 January 2005 (“Trial Judgement”);¹

NOTING the Appeals Chamber’s decision of 7 June 2007² reopening the respective appeals of Pavle Strugar and the Prosecution against the Trial Judgement;

NOTING that the briefing on appeal in this case is complete³ and that the oral arguments of the parties were heard by the Appeals Chamber on 23 April 2008;

CONSIDERING that, for urgent personal reasons, Judge O-Gon Kwon will be unable to be present at the delivery of the judgement on Appeals in this case (“Appeal Judgement”);

NOTING that pursuant to Article 15bis(A) of the Rules of Procedure and Evidence of the International Tribunal (“Rules”), “[i]f a Judge is, for illness or other urgent personal reasons, or for reasons of authorised Tribunal business, unable to continue sitting in a part-heard case for a period which is likely to be of short duration, and (ii) the remaining Judges of the Chamber are satisfied that it is in the interests of justice to do so, those remaining Judges of the Chamber may order that the hearing of the case continue in the absence of that Judge for a period of not more than five working days”;⁴

CONSIDERING that the remaining Judges of the Appeals Chamber are convinced that it is in the interests of justice to deliver the Appeal Judgement despite the absence of Judge O-Gon Kwon;

PURSUANT TO Rules 15bis(A) and 117(D) of the Rules,


