ORDER DESIGNATING A PRE-TRIAL JUDGE

I, O-GON KWON, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

NOTING the Indictment in *Prosecutor v. Stojan Župljanin*, which was filed on 6 October 2004;

NOTING that Stojan Župljanin was transferred to the seat of the Tribunal on 21 June 2008;

NOTING the Order issued on 11 June 2008 by the President of the Tribunal assigning the case against Stojan Župljanin to Trial Chamber II;

NOTING the Order issued on 23 June 2008 by the Presiding Judge of Trial Chamber II regarding the composition of the Trial Chamber;

CONSIDERING Article 13 *quater*(1)(d) of the Statute of the Tribunal (“Statute”) enabling *ad litem* judges of the Tribunal to adjudicate in pre-trial proceedings;

CONSIDERING that Rule 65 *ter*(A) of the Tribunal’s Rules of Procedure and Evidence (“Rules”) provides that the Presiding Judge of the Trial Chamber shall “designate from among its members a Judge responsible for the pre-trial proceedings” (“Pre-Trial Judge”);

NOTING the powers of a Pre-Trial Judge as set out in Rule 65 *ter* of the Rules;


PURSUANT TO Article 13 *quater* of the Statute and Rules 54 and 65 *ter* of the Rules;

DESIGNATE:

Judge Ole Bjørn Støle as Pre-Trial Judge for this case.
