I, THEODOR MERON, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the Former Yugoslavia since 1991 ("Tribunal"), and Pre-Appeal Judge in this case,

RECALLING the Scheduling Order issued on 11 July 2008 ordering that a status conference

he is unable to appear at the status conference on 21 July 2008 and requesting permission for Ms.

Quincy Whitaker and Ms. Michelle Butler, Legal Consultants assigned to the Amicus Curiae team,

to appear in this status conference in his place, also via tele-conference;

NOTING that *Amicus Curiae* is not a party to the proceedings and has a mandate of assisting the

Appeals Chamber, therefore the substitution of qualified legal consultants for named Amicus

Curiae counsel, for the limited purposes of appearing at a status conference, does not prejudice any

of the parties;

NOTING also the letter received on 14 July 2008 from counsel for Momčilo Krajišnik on the issue

of JCE liability, Mr. Alan Dershowitz, requesting permission to participate in the status conference

on 21 July 2008 via tele-conference;

CONSIDERING that pursuant to Rule 65bis(C) of the Rules a status conference may be conducted

with the participation of counsel via tele-conference or video-conference;

PURSUANT TO RULES 54, 65 BIS(C), AND 107 OF THE RULES

HEREBY VARY the 11 July 2008 Scheduling Order to the effect that Ms. Quincy Whitaker and

Ms. Michelle Butler shall appear in the status conference on 21 July 2008 in the place of Mr. Colin

Nicholls via tele-conference;
