**TRIAL CHAMBER III** (“Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**CONSIDERING** that Counsel for the Accused Prlić (“Prlić Defence”), the Office of the Prosecutor (“Prosecution”), Counsel for the Accused Stojić (“Stojić Defence”) and Counsel for the Accused Petković (“Petković Defence”) requested the admission respectively of 80,<sup>1</sup> 31,<sup>2</sup> 17,<sup>3</sup> and 2<sup>4</sup> exhibits relative to the testimony of Mile Akmadžić (“Proposed Exhibits”) who appeared in court on 16 and 24 June 2008,

**CONSIDERING** that the Chamber has heard the objections formulated by the Prosecution with regard to certain of the Proposed Exhibits,<sup>5</sup>

**CONSIDERING** that the Chamber has examined each one of the Proposed Exhibits based on the admissibility criteria defined in the Decision on Admission of Evidence, rendered by the Chamber on 13 July 2006 (“Decision of 13 July 2006”), and in the Decision Adopting Guidelines for the Presentation of Defence Evidence, rendered by the Chamber on 24 April 2008 (“Decision of 24 April 2008”),<sup>6</sup>

**CONSIDERING** that the Chamber decides to admit into evidence the exhibits marked “admitted” in the Annex attached to this decision since they were presented to Witness Mile Akmadžić and bear sufficient indicia of reliability, relevance and probative value,

**CONSIDERING** that the Chamber decides not to admit into evidence the Proposed Exhibits marked “not admitted” in the Annex attached to this decision because they do not comply with the instructions set out in the Decision of 13 July 2006 and the Decision of 24 April 2008

**DECIDES** to admit into evidence the Proposed Exhibits marked “admitted” in the Annex attached to this decision,

**DENIES** the requests of the Prlić Defence, the Stojić Defence and the Prosecution in all other respects for the reasons set out in the Annex attached to this decision **AND**

**DECLARES MOOT** the requests of the Prlić Defence and the Prosecution with regard to Exhibits 1D 00507, 1D 00942, 1D 02431, P 10484 and P 10485, for the reasons set out in the Annex attached to this decision.
