**TRIAL CHAMBER III** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

**CONSIDERING** that Counsel for the Accused Prlić ("Prlić Defence") and the Office of the Prosecutor ("Prosecution") requested respectively the admission of 50<sup>1</sup> and 10<sup>2</sup> exhibits relative to the testimony of Žarko Primorac ("Proposed Exhibits") who appeared from 24 to 26 June 2008,

**CONSIDERING** that none of the Parties made any objections to the admission of the Proposed Exhibits,

**CONSIDERING** that nine of the exhibits proposed by the Prlić Defence are not on the list of exhibits filed by the Prlić Defence pursuant to Rule 65 *ter* of the Rules of Procedure and Evidence ("65 *ter* List") and that the Prlić Defence asked during the hearing of 25 June 2008 that they be added to the 65 *ter* List in order to present them to Witness Žarko Primorac ("Request to Add Exhibits to the 65 *ter* List"),<sup>3</sup>

**CONSIDERING** that neither the Prosecution nor the other Defence teams objects to the Request to add exhibits to the 65 *ter* List,<sup>4</sup>

**CONSIDERING** that the Chamber decides, after a *prima facie* examination of the reliability, relevance and probative value of exhibits 1D 02941, 1D 02942, 1D 02943, 1D 02944, 1D 02945, 1D 02947, 1D 02948 and 1D 02949, that they may be added to the 65 *ter* List,

**CONSIDERING** nevertheless that the Chamber notes that the Prlić Defence did not use Exhibit 1D 02946 during the hearing of Witness Žarko Primorac; consequently, that the Chamber considers that this exhibit is not essential for the Prlić Defence and thus there is no cause to add it to the 65 *ter* List,

CONSIDERING that the Chamber has examined each one of the Proposed Exhibits on the basis of the admission criteria defined in the Decision on Admission of

Evidence rendered by the Chamber on 13 July 2006 ("Decision of 13 July 2006"), and in the Decision Adopting Guidelines for the Presentation of Defence Evidence rendered by the Chamber on 24 April 2008 ("Decision of 24 April 2008),<sup>5</sup>

CONSIDERING that the Chamber decides to admit into evidence the Proposed Exhibits marked "admitted" in the Annex attached to this decision since they were presented to Witness Žarko Primorac and bear sufficient indicia of reliability, relevance and probative value,

**CONSIDERING** that the Chamber decides not to admit into evidence the Proposed Exhibits marked "not admitted" in the Annex attached to this decision since they do not comply with the instructions set out in the Decisions of 13 July 2006 and 24 April 2008.

#### FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence,

**AUTHORISES** the Prlić Defence to add exhibits 1D 02941, 1D 02942, 1D 02943, 1D 02944, 1D 02945, 1D 02947, 1D 02948 and 1D 02949 to the 65 *ter* List,

**DENIES** the Prlić Defence request to add Exhibit 1D 02946 to the 65 ter List,

**PARTIALLY GRANTS** the requests for admission of the Prlić Defence and the Prosecution,

**DECIDES** to admit into evidence the Proposed Exhibits marked "admitted" in the Annex attached to this decision,

**DENIES** in all other respects the requests for admission by the Prlić Defence and the Prosecution for the reasons set out in the Annex attached to this decision **AND** 

**DECLARES MOOT** the request by the Prlić Defence with regard to Exhibit 1D 01773 for the reason set out in the Annex attached to this decision,
