I, FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal"),

**NOTING** the "Tarčulovski Motion for Extension of Time to File the Notice of Appeal", filed on 22 July 2008, whereby the Defence of Johan Tarčulovski requests that the Appeals Chamber grant it an extension of time of one month to file the Notice of Appeal;

**CONSIDERING** Articles 12(3), 14(3) and 25 of the Statute of the International Tribunal and Rule 108 of the Rules of Procedure and Evidence of the International Tribunal ("Rules");

**CONSIDERING** the composition of the Appeals Chamber of the International Tribunal as set out in document IT/245 issued on 12 May 2006;

**CONSIDERING** that pursuant to Article 14(2) of the Statute of the International Tribunal, I am the Presiding Judge on all appeals cases on which I sit;

**CONSIDERING** that pursuant to Rules 65ter and 107 of the Rules, as Presiding Judge, I shall designate a Pre-Appeal Judge responsible for pre-appeal proceedings in this case;

HERBY ASSIGN myself as Pre-Appeal Judge; and
