**I, JUDGE ALPHONS ORIE**, Presiding Judge in Trial Chamber I of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the operative Amended Indictment in the case *Prosecutor v. Radovan Karadžić*, Case No. IT-95-5/18-I, filed on 24 May 2000 and confirmed on 31 May 2000;

**NOTING** that **RADOVAN KARADŽIĆ** (“the Accused”) was arrested in Serbia on 21 July 2008 and transferred to the seat of the Tribunal on 30 July 2008;

**NOTING** the “Order Assigning a Case to a Trial Chamber” issued by the President of the Tribunal on 22 July 2008, which assigned the case *Prosecutor v. Radovan Karadžić* to Trial Chamber I, which is now in effect;

**NOTING** that the initial appearance of the Accused is scheduled to be held on 31 July 2008;

**CONSIDERING** Rule 65 *ter* (A) of the Tribunal’s Rules of Procedure and Evidence (“Rules”) which provides that the Presiding Judge of the Trial Chamber shall designate from among its members a Judge responsible for the pre-trial proceedings (“Pre-Trial Judge”);

**PURSUANT TO** Article 14 (7) of the Statute of the Tribunal and Rules 54 and 65 *ter* (A) of the Rules;

**HEREBY ORDER** that the Trial Chamber in the case *Prosecutor v. Radovan Karadžić* shall be composed as follows:


Judge Alphons Orie, Presiding

**DESIGNATE** myself, Judge Alphons Orié, as Pre-Trial Judge in this case.
