### ORDER ADMITTING EVIDENCE RELATED TO WITNESS ZORAN BUNTIĆ

**TRIAL CHAMBER III** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

CONSIDERING that Counsel for the Accused Prlić ("Prlić Defence") requested the admission of 105 exhibits<sup>1</sup> while Counsel for the Accused Stojić ("Stojić Defence"), Counsel for the Accused Praljak ("Praljak Defence"), Counsel for the Accused Petković ("Petković Defence"), Counsel for the Accused Ćorić ("Ćorić Defence"), and the Office of the Prosecutor ("Prosecution") requested the admission of 16,<sup>2</sup> 1,<sup>3</sup> 12,<sup>4</sup> 27<sup>5</sup> and 8<sup>6</sup> exhibits, respectively, related to the testimony of Zoran Buntić ("Proposed Exhibits") who appeared from 7 to 18 July 2008,

**CONSIDERING** that among the Proposed Exhibits, the Praljak Defence requests the admission of Exhibit 3D 03216 under Rule 92 *ter* of the Rules of Procedure and Evidence ("Rules"), <sup>7</sup>

CONSIDERING that the Chamber has considered the Prosecution objections against the admission of certain Proposed Exhibits offered by the Prlić Defence<sup>8</sup> and Petković Defence, but notes that the Prosecution does not object to the admission of Proposed Exhibits offered by the Stojić Defence, Praljak Defence and Ćorić Defence,

CONSIDERING that the Prosecution objects to the admission of Exhibits 1D 01596, 1D 01597, 1D 01598, 1D01599, 1D 01600, 1D 01601 and 1D 01602, offered by the Prlić Defence, on the ground that these documents were read out loud to the witness by Counsel for the Accused Prlić, but that no question was put to the witness in respect of them, <sup>10</sup>

**CONSIDERING** that the Prosecution objects to the admission of Exhibits 1D 01974, 1D 02015, 1D 02005, 1D 02341, 1D 02378, 1D 02377, 1D 02376, 1D 02369, 1D 02375, 1D 02374, 1D 02368, 1D 01777, 1D 01797, 1D 02285, 1D 01976, 1D 02372 and 1D 02909, offered by the Prlić Defence, on the ground that the witness was unable to inform the Chamber as to the reliability, relevance or probative value of the document,<sup>11</sup>

**CONSIDERING** that the Prosecution objects to the admission of Exhibit 1D 01672, offered by the Petković Defence, on the ground that the witness was unable to inform the Chamber as to the reliability, relevance or probative value of the document, <sup>12</sup>

CONSIDERING that the Chamber notes that, contrary to the Prosecution's assertion, the Prlić Defence did not request the admission of Exhibit 1D 01602, <sup>13</sup>

CONSIDERING that the Chamber is of the view that Witness Zoran Buntić is not the appropriate witness to discuss the reliability, relevance or probative value of Exhibits 1D 01596, 1D 01597, 1D 01598, 1D01599, 1D 01600, 1D 01601, which are letters regarding the establishment of a provisional government for the Republic of Bosnia and Herzegovina, 14

CONSIDERING moreover that the Prlić Defence did not truly give Witness Zoran Buntić the opportunity to comment individually on Exhibits 1D 01777, 1D 01974, 1D 02005, 1D 02015, 1D 02285, 1D 02341, 1D 02368, 1D 02369, 1D 02372, 1D 02374, 1D 02375, 1D 02376, 1D 02377 and 1D 02378, 15

CONSIDERING that concerning Exhibits 1D 01672, 1D 01797 and 1D 01976, the Chamber considers that, contrary to the Prosecution's submission, Witness Zoran Buntić was able to comment on the reliability, relevance or probative value of the exhibit, 16

CONSIDERING that with regard to Exhibit 1D 02909, the Prlić Defence failed to specify which pages of this document it requests for admission as required by

paragraph 30 of the Decision Adopting Guidelines for the Presentation of Defence Evidence, rendered by the Chamber on 24 April 2008 ("Decision of 24 April 2008"),

**CONSIDERING** that the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria set out in the Decision on Admission of Evidence, rendered by the Chamber on 13 July 2006 ("Decision of 13 July 2006"), and in the Decision of 24 April 2008,<sup>17</sup>

CONSIDERING that the Chamber decides to admit into evidence the Proposed Exhibits indicated "Admitted" in the annex attached to this decision, because they were put to Witness Zoran Buntić in court and bear sufficient indicia of relevance, reliability and probative value,

CONSIDERING that the Chamber decides not to admit into evidence the Proposed Exhibits indicated "Not Admitted" in the annex attached to this decision, because they fail to satisfy the requirements set out in the Decisions of 13 July 2006 and 24 April 2008.

#### FOR THESE REASONS.

IN ACCORDANCE with Rules 54 and 89 of the Rules,

GRANTS the requests for admission from the Praljak Defence and Corić Defence,

PARTIALLY GRANTS the requests for admission from the Prlić Defence, Stojić Defence, Petković Defence, and the Prosecution,

**ADMITS** into evidence the Proposed Exhibits indicated "Admitted" in the Annex attached to this decision,

**DENIES** in all other respects the requests for admission from the Prlić Defence, Stojić Defence, Petković Defence and the Prosecution, for the reasons set out in the Annex to this decision, **AND**
