THE APPEALS CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the

Territory of the Former Yugoslavia since 1991 ("Appeals Chamber" and "Tribunal", respectively);

RECALLING its confidential "Decision on Prosecution's Motion to Adduce Rebuttal Material" of

8 October 2008, wherein it called Mr. George Mano and Mr. Stefan Karganović to appear as

witnesses of the Appeals Chamber under Rules 98 and 107 of the Rules of Procedure and Evidence

of the Tribunal ("Rules") at an evidentiary hearing on 3 and 5 November 2008 ("Evidentiary

Hearing"), to give evidence relating to the conduct of Mr. Nicholas Stewart QC as counsel in

Momčilo Krajišnik's ("Appellant") defence team at trial;¹

RECALLING its "Decision on Appellant Momčilo Krajišnik's Motion to Call Radovan Karadžić

Pursuant to Rule 115" of 16 October 2008, wherein the Appeals Chamber ordered the Appellant to

contact Radovan Karadžić to appear as a witness at the Evidentiary Hearing under Rule 115 of the

Rules;²

HEREBY INFORMS the Parties and Amicus Curiae that the Evidentiary Hearing will be held in

accordance with the following arrangements:

1) Mr. George Mano and Mr. Stefan Karganović will be heard during the session on

3 November 2008. This session is to commence at 08:30 hours and to end at 19:00 hours;

2) Mr. Radovan Karadžić will be heard during the session on 5 November 2008. This session

is to commence at 08:30 hours and to end at 19:00 hours;

3) Each session will include breaks at suitable moments, to be announced by the Appeals

Chamber during the session;

4) The courtroom in which the Evidentiary Hearing will be held will be announced in due

course;

DIRECTS the Registrar to communicate this scheduling order to Mr. George Mano, Mr. Stefan

Karganović and Mr. Radovan Karadžić and to make the necessary arrangements for them to appear

at the Evidentiary Hearing;

DIRECTS the Registrar to inquire, and to inform the Appeals Chamber as soon as practicable,

whether Mr. Radovan Karadžić wishes to exercise his right to be assisted by counsel at the

Evidentiary Hearing, and, if he does, to arrange for counsel to be assigned for the purposes of the

Evidentiary Hearing; and

Decision on Prosecution's Motion to Adduce Rebuttal Material (confidential), 8 October 2008, paras 10, 11 and 16.

DIRECTS the Registrar to segregate Mr. Radovan Karadžić from the Appellant for the duration of Mr. Radovan Karadžić's testimony in the present case.
