NOTING the "Order Designating the State in which Goran Jelisić is to serve his Prison Sentence",

filed confidentially on 21 August 2001, which designated Italy as the state in which Goran Jelisić is

to serve his sentence ("Order of 21 August 2001");

NOTING the "Order Setting Aside the Order of 21 August 2001 and Designating Norway as the

State in which Goran Jelisić is to Serve His Sentence", filed on 6 November 2001, which

designated Norway as the state in which Goran Jelisić is to serve his sentence ("Order of 6

November 2001");

NOTING the "Amended Order Designating the State in Which Goran Jelisić is to Serve his

Sentence", filed confidentially on 2 April 2003, which designated Italy as the state in which Goran

Jelisić is to serve his sentence ("Order of 2 April 2003");

CONSIDERING that Goran Jelisić has since been transferred to Italy;

CONSIDERING therefore that the reason for issuing all of the Orders on a confidential basis is no

longer applicable;

HEREBY INSTRUCT the Registry of the International Tribunal to lift the confidential status of

the Orders, and **ORDER** that the Order of 21 August 2001, the Order of 6 November 2001 and the

Order of 2 April 2003 shall henceforth all be considered public filings.
