## ORDER REQUESTING SUBMISSIONS ON A MOTION PURSUANT TO RULE 13

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**BEING SEIZED OF** the "Urgent Motion Regarding a Breach of Non-Bis-In-Idem", filed by Counsel for Naser Orić on 11 December 2008 ("Motion");

**NOTING** the "Order Assigning a Chamber to Consider a Motion Pursuant to Rule 13", issued on 15 December 2008, in which the Motion was assigned by the Acting President to Trial Chamber II ("Order");

**NOTING** that the Prosecution seeks in the Motion an Order that the Municipal Prosecutor's Office in Bijeljina in Republika Srpska in Bosnia and Herzegovina ("Municipal Prosecutor's Office") permanently discontinue proceedings (KT-11/01, KT-12/01, KT-70/97 and KT-26/01) against Naser Orić on the grounds that they are in breach of the principle of *non bis in idem*; <sup>1</sup>

**NOTING** Article 10 of the Statute of the Tribunal and Rule 13 of the Rules of Procedure and Evidence ("Rules");

**CONSIDERING** that the submissions of the Municipal Prosecutor's Office on the Motion would be of assistance to the Trial Chamber in determining whether there has been a breach of the principle of *non bis in idem* and that such determination should be undertaken expeditiously;

PURSUANT TO Rules 13 and 54

**HEREBY ORDERS** that the Registry shall provide the Municipal Prosecutor's Office with the Motion and the Order and that the Municipal Prosecutor's Office may file submissions on the Motion no later than 19 January 2009.
