BEING SEISED OF "Request on Behalf of Milan Gvero Pursuant to Rule 127 (A)(i)", filed on 5 January 2009 ("Request"), in which the Gvero Defence requests an extension of time to file a reply to the Miletić Defence's "Réponse du Général Miletić à la requête de Milan Gvero aux fins d'admission de trois déclarations de Djordje Djukić en application de l'Article 92 quater du Règlement" ("Miletić Response"), filed on 29 December 2008, opposing the "Motion on behalf of Milan Gvero seeking the admission into evidence of three statements of Djorde Djukić pursuant to Rule 92 quater", filed on 16 December 2008;
