TRIAL CHAMBER III ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

RECALLING that the Trial Chamber in *Prosecutor v. Mitar Vasiljević* granted the protective measures of pseudonym and image distortion to the following Prosecution witnesses, who have testified in open session for the purposes of the current proceedings: VG-013, VG-018, VG-038, VG-078¹ and VG-115, ² ("Prosecution Witnesses");

NOTING that the said protective measures continue to have effect for the purposes of the present proceedings pursuant to Rule 75(F) of the Rules of Procedure and Evidence ("Rules");

NOTING that the Trial Chamber in the current proceedings heard portions of the testimony of witnesses VG-013,3 VG-018,4 VG-0385, VG-0786 and VG-1157 in private session, owing to concerns that information identifying these witnesses, as well as other witnesses in the current proceedings in respect of whom protective measures are in force, not be publicised;

RECALLING that on 15 December 2008, the Trial Chamber heard submissions from the Defence of Milan Lukić ("Defence") concerning, inter alia, the Defence's ability to open its case and the availability of three of its witnesses ("Defence Witnesses");

RECALLING that during the 15 December 2008 hearing, the Trial Chamber called the Chief of the Registry's Victims and Witnesses Section ("VWS") to address the Chamber regarding, inter alia, the travel arrangements of the Defence Witnesses;

RECALLING that portions of the 15 December 2008 hearing were conducted in private session due to concerns that the subject-matter addressed during the said hearing contained references to personal information of protected Defence Witnesses;8

NOTING that pursuant to Rule 81(B) the Trial Chamber, after giving due consideration to any matters relating to witness protection, may order the disclosure of all or part of the record of closed proceedings when the reasons for ordering its non-disclosure no longer exist;
