THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991;

BEING SEISED OF "Vujadin Popović's Request for an Extension of Time to File a Response to the Prosecution's Motion to Admit Evidence in Rebuttal under Rule 85(A) and to Reopen its Case with Appendices A-G, with Confidential Annex", filed on 16 March 2009 ("Request"), requesting an extension of time, until midnight of Thursday 19 March 2009, to respond to the confidential "Prosecution Motion to Admit Evidence in Rebuttal under Rule 85(A) and to Reopen its Case with Appendices A-G", filed on 2 March 2009 ("Motion");

NOTING that on 5 March 2009, Popović asked for clarification of the content of Mr. Janc's report, one of the witnesses proposed in the Motion for the reopening of the Prosecution case, to which the Prosecution has not responded and that the Prosecution only disclosed Mr. Janc's report on Friday 14 March 2009 at 6:09 p.m.;¹

CONSIDERING that good cause has been shown;

PURSUANT TO Rule 127 (A)(i) of the Rules of Procedure and Evidence,

HEREBY PARTLY GRANTS the Request and **ORDERS** that Popović files the response to the Motion by midnight of Tuesday 17 March 2009.
