THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

BEING SEISED of a "First Prosecution Motion for Judicial Notice of Adjudicated Facts", filed on 27 October 2008 ("First Motion") and a "Second Prosecution Motion for Judicial Notice of Adjudicated Facts and *Corrigendum* to First Prosecution Motion for Judicial Notice of Adjudicated Facts" filed on 17 March 2009 ("Second Motion);

CONSIDERING that in the *Corrigendum* contained within the Second Motion the Office of the Prosecutor ("Prosecution") withdraws the first sentence of proposed fact 342 in the First Motion;

CONSIDERING that the parties were informed by the Pre-Trial Judge at the Status Conference held on 28 October 2008 that the First Motion would be dealt with after the issue of amendment of the Indictment was resolved, and that the Accused was not required to file his response to that Motion within the normal 14 day period;

NOTING that the Accused received a translation of the First Motion into BCS on 25 November 2008;

PURSUANT TO Rules 54, 126 *bis*, and 127 of the Tribunal's Rules of Procedure and Evidence;

HEREBY ORDERS the Accused to file any response to the First Prosecution Motion for Judicial Notice of Adjudicated Facts within 14 days of this Order.
