I, PATRICK ROBINSON, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal"),

NOTING the "Order Assigning a Case to a Trial Chamber", issued by the President of the International Tribunal on 11 March 2005, assigning *Prosecutor v. Mićo Štanišić*, Case No. IT-04-79-I, to Trial Chamber II;

NOTING the "Order Regarding Composition of Trial Chamber", issued by the Presiding Judge of Trial Chamber II on 11 July 2008, ordering that the Trial Chamber for the purposes of pre-trial proceedings in *Prosecutor v. Mićo Štanišić*, Case No. IT-04-79-PT, be composed of Judge O-Gon Kwon, Presiding, *ad litem* Judge Kimberly Prost, and *ad litem* Judge Ole Bjørn Støle;

NOTING the "Order Assigning a Case to a Trial Chamber", issued by the President of the International Tribunal on 11 June 2008, assigning *Prosecutor v. Stojan Župljanin*, Case No. IT-99-36-I, to Trial Chamber II;

NOTING the "Order Regarding Composition of Trial Chamber", issued by the Presiding Judge of Trial Chamber II on 11 July 2008, ordering that the Trial Chamber for the purposes of pre-trial proceedings in *Prosecutor v. Stojan Župljanin*, Case No. IT-99-36/2-I, be composed of Judge O-Gon Kwon, Presiding, *ad litem* Judge Kimberly Prost, and *ad litem* Judge Ole Bjørn Støle:

NOTING the "Decision on Prosecution's Motion for Joinder and for Leave to Consolidate and Amend Indictments", issued by Trial Chamber II on 23 September 2008, in which Trial Chamber II, *inter alia*, ordered that *Prosecutor v. Mićo Štanišić*, Case No. IT-04-79-PT and *Prosecutor v. Stojan Župljanin*, Case No. IT-99-36/2-PT be joined;

NOTING that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President to coordinate the work of the Chambers;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

HEREBY REASSIGN, with immediate effect, *Prosecutor v. Mićo Štanišić and Stojan Župljanin*, Case No. IT-08-91-PT, to Trial Chamber III;

AND ASSIGN, with immediate effect, *ad litem* Judge Ole Bjørn Støle and *ad litem* Judge Frederik Harhoff to Trial Chamber III for the purposes of pre-trial work in *Prosecutor v. Mićo Štanišić and Stojan Župljanin*, Case No. IT-08-91-PT.
