**THE SPECIALLY APPOINTED CHAMBER** (“Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”), as reconstituted by the President of the Tribunal on 2 April 2009;<sup>1</sup>

**BEING SEISED OF** the “Prosecution Motion to Amend Rule 65*ter* Witness List”, filed publicly by the *Amicus Curiae* Prosecutor on 4 February 2009 (“Motion”);

**NOTING** that the *Amicus Curiae* Prosecutor requests to further amend the list of witnesses he intends to call at trial by removing Ms. Evelyn Anoya from the witness list because “it has been concluded that her testimony is no longer necessary for the Prosecution case”;<sup>2</sup>


**NOTING** that the Defence has not filed a response to the Motion;

**CONSIDERING** that in the instant case, it is in the interests of justice to shorten the Prosecution’s witness list, which will not result in any prejudice to the accused;

**FOR THE FOREGOING REASONS** and pursuant to Rules 54 and 65 *ter* of the Tribunal’s Rules of Procedure and Evidence;

**HEREBY GRANTS** the Motion.
