THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

BEING SEISED of the Accused's "Second Motion for Order Pursuant to Rule 70", filed on 11 May 2009 ("Motion"), whereby the Accused requests the Trial Chamber to issue an order pursuant to Rules 54 and 70 of the Rules of Procedure and Evidence of the Tribunal ("Rules") to the effect that the provisions of Rule 70 should apply to any information provided by Mr. Lawrence Butler, an official of the Government of the United States of America ("U.S. Government") in an interview with the Accused's legal associate;¹

NOTING that the Accused has not submitted with the Motion any confirmatory material from the U.S. Government but merely states that the U.S. Government has required a Rule 70 order as a condition to the interview of its personnel,² and that an interview with Mr. Butler is being arranged for the week of 18 May 2009;³

CONSIDERING that, in order to determine the Motion, the Trial Chamber needs to be satisfied that the U.S. Government has consented to produce the information sought through Mr. Butler on the condition that the provisions of Rule 70 will apply;

CONSIDERING that the Motion suggests that the proposed interview is imminent and that the Trial Chamber would be assisted by any information and comments the U.S. Government can provide on its communication with the Accused to that effect, on an urgent basis;
