THE APPEALS CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”);

RECALLING that, during the last status conference on 11 March 2009, the Pre-Appeal Judge discussed with the parties the appropriate date for the oral arguments in these appellate proceedings;¹

NOTING that Rule 114 of the Rules provides that “[a]fter the expiry of the time-limits for filing the briefs provided for in Rules 111, 112 and 113, the Appeals Chamber shall set the date for the hearing and the Registrar shall notify the parties”;

ORDERS that Ramush Haradinaj and Idriz Balaj shall inform the Appeals Chamber and the Registry in writing, by no later than 2 September 2009, if they will exercise their right to be present during the appeal hearing as provided for in Article 21(4)(d) of the Statute of the International Tribunal, so that appropriate arrangements can be made for their transfer to the seat of the International Tribunal.
