## ORDER ASSIGNING *AD LITEM* JUDGES TO A CASE BEFORE A TRIAL CHAMBER

**NOTING** the letter of the Secretary-General of the United Nations dated 6 August 2009 appointing Judge Melville Baird as an *ad litem* Judge to serve in the International Tribunal for the trial of Case No. IT-95-5/18, *Prosecutor v. Radovan Karadžić*;

**NOTING** the letter of the Secretary-General of the United Nations dated 6 August 2009 appointing Judge Flavia Lattanzi as an *ad litem* Judge to serve in the International Tribunal for the trial of Case No. IT-95-5/18, *Prosecutor v. Radovan Karadžić*;

**NOTING** the "Order Reassigning a Case to a Trial Chamber," issued by the President of the International Tribunal on 21 August 2008, which reassigned *Prosecutor v. Radovan Karadžić*, Case No. IT-95-5/18-I, from Trial Chamber I to Trial Chamber III;

**NOTING** that President Patrick Robinson is currently absent from the International Tribunal and that, pursuant to Rule 21 of the Rules of Procedure and Evidence of the International Tribunal ("Rules"), the Vice-President shall exercise the functions of the President in case of the latter's absence or inability to act;

CONSIDERING Articles 12, 13, 13ter(2) and 14(5) of the Statute;

**NOTING** that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President of the International Tribunal to coordinate the work of the Chambers;

**CONSIDERING** the composition of the Trial Chambers of the International Tribunal as set out in document IT/266 issued on 2 September 2009;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

**HEREBY ASSIGN,** with immediate effect, Judges Melville Baird and Flavia Lattanzi to Trial Chamber III for the trial of Case No. IT-95-5/18, *Prosecutor v. Radovan Karadžić*.
