I, O-Gon Kwon, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal"),

**NOTING** that, in accordance with Rule 65bis of the Tribunal's Rules of Procedure and Evidence ("Rules"), a Status Conference was held on 8 September 2009, and that during this Status Conference, and after hearing the parties, I made a number of orders and decisions on behalf of the Trial Chamber relating to the pre-trial management of the case;

**CONSIDERING** that for the purposes of clarity and to assist the ongoing preparations for trial a number of these orders are set out below with any necessary modifications;

## PURSUANT TO Rules 54, 65ter(B) and 73bis of the Rules, HEREBY,

- GRANT the Accused's request for an extension of time to respond to the "Fourth Prosecution Motion for Judicial Notice of Adjudicated Facts", in part, and extend the deadline for the Accused's response to 30 November 2009.
- 2. **REQUEST** the Registry to file as confidential the annexes to the Accused's "Submission of Response to Prosecution Rule 92 *bis* Motion Expert Witnesses" until further order.
- 3. **ORDER** the Accused, in consultation with the Prosecution and the Registry, to make any necessary redactions to the translated version of the annexes, once this has taken place, and file this translated, redacted version publicly.
- 4. **INVITE** the Prosecution to make further submissions pursuant to Rule 73bis of the Rules by 18 September 2009, and the Accused to file a response to the Prosecution submissions, if he so wishes, by 30 September 2009.

5. **INVITE** the parties to make submissions on all aspects of the procedure to be followed during trial by 28 September 2009.
