NOTING that the Deputy Registrar of the Tribunal appointed Mihajlo Bakrač and Vladimir Petrović respectively as lead counsel and co-counsel for Franko Simatović on 11 September 2009;³

PURSUANT TO Rule 54 of the Rules of Procedure and Evidence of the Tribunal

HEREBY ORDERS that a hearing shall be held on Monday 14 September 2009, commencing at 2.15 p.m., in Courtroom II.
