**TRIAL CHAMBER II** (“Trial Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**BEING SEISED** of the “Prosecution’s fifth motion for protective measures for victims and witnesses scheduled to testify imminently with annex A”, filed confidentially today, 22 September 2009 (“Motion”), in which the Prosecution seeks (a) the grant of additional protective measures for witness ST-056<sup>1</sup>; and (b) requests confirmation that the protective measures granted in respect of witness ST-027 remain in effect;


**NOTING** the provisions of Rule 126 *bis* of the Rules of Procedure and Evidence as to the time for filing of responses to motions;

**CONSIDERING** the current trial schedule in this case and that it is in the interest of good case management to require an expedited response to the Motion by both the Defence of Mićo Stanišić and the Defence of Stojan Župljanin (together “the Defence”);

**PURSUANT TO** Rules 54 and 126 *bis* of the Rules;

**ORDERS** the Defence to file their responses, if any, to the Motion by 4 p.m. on Thursday, 24 September 2009.
