**I, Patrick Robinson**, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”),

**NOTING** the confidential “Notice of Appeal of Florence Hartmann Against the Judgment of the Specially Appointed Trial Chamber” (“Notice of Appeal”), filed by Counsel for Florence Hartmann on 24 September 2009;<sup>1</sup>

**CONSIDERING** Articles 12(3) and 14(3) of the Statute of the International Tribunal (“Statute”) and Rule 77 of the Rules of Procedure and Evidence of the International Tribunal (“Rules”);

**CONSIDERING** the composition of the Appeals Chamber of the International Tribunal as set out in document IT/263 issued on 11 May 2009;

**CONSIDERING** that pursuant to Article 14(2) of the Statute, I am the Presiding Judge on all appeal cases on which I sit;

**CONSIDERING** that pursuant to Rules 65<sup>ter</sup> and 107 of the Rules, as Presiding Judge, I shall designate a Pre-Appeal Judge responsible for pre-appeal proceedings in this case;

**HEREBY ASSIGN** myself as Pre-Appeal Judge; and

**HEREBY ORDER** that the Bench in *In the Case Against Florence Hartmann*, Case No. IT-02-54-R77.5-A, shall be composed as follows:

Judge Burton Hall


