**NOTING** that at the last Status Conference, held on 8 September 2009, I indicated that the trial in the present case would commence on 19 October 2009, and that there would be a pre-trial conference on 6 October 2009;



**PURSUANT TO** Rules 54, 65 *ter* (B), and 73 *bis* of the Rules;

**HEREBY SCHEDULE** the pre-trial conference for **Tuesday, 6 October 2009** at 2:15 p.m. in Courtroom 1.
