# DECISION ON REQUEST FROM THE GOVERNMENT OF THE REPUBLIC OF GREECE

## Office of the Prosecutor

**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal") is seised of a request from the Government of the Republic of Greece of 13 October 2009 ("Request"), and hereby renders its decision thereon.

1. The Trial Chamber is currently seised of the "Motion for Binding Order: Government of Greece" filed publicly by the Accused on 28 September 2009 ("Motion"). In the Motion, the Accused acknowledges that the Government of Greece ("Greek Government") should have the opportunity to be heard before a binding order is issued.<sup>1</sup> The Office of the Prosecutor did not respond to the Motion.

2. On 30 September 2009, in order to be assisted in deciding the Accused's Motion, the Trial Chamber invited the Greek Government to respond by no later than 16 October 2009.<sup>2</sup>

3. On 13 October 2009, the Greek Government filed the present Request indicating that it needed more time to consult the relative authorities and to further examine the documents in order to determine whether their production might be prejudicial to national security interest.<sup>3</sup> Noting that this procedure involves extensive research into a great number of files in the archives of various ministries and services, the Greek Government requests an extension until 16 November 2009 to respond.<sup>4</sup>

4. The Trial Chamber considers that it is in the interests of all parties involved that requests for documents from states are, if possible, dealt with on a voluntary basis. It is equally important that these requests are dealt with expeditiously, especially in light of the imminent start of the trial in the present case, which is set for 26 October 2009.<sup>5</sup> Therefore, the Trial Chamber considers it appropriate to invite the Greek Government to respond to the Motion by 29 October 2009, in the hope that the documents sought can be identified and provided to the Accused as soon as possible.
