## Background

1. During the Prosecution's case, the Chamber admitted into evidence a number of documents pursuant to Rules 92 *bis* and 92 *quater* of the Tribunal's Rules of Procedure and Evidence ("Rules").<sup>1</sup> Most of the documents admitted under these Rules were initially admitted under seal, in order to give the Prosecution an opportunity to consider whether any protective measures would be necessary for the documents. The Prosecution informed the Chamber about its position and in most instances clarified that it would not seek any protective measures.<sup>2</sup>
2. After informal discussions between Chamber's staff and the Prosecution in July 2009, the Prosecution decided to upload into eCourt redacted versions of selected witness statements, in order to protect from the public potentially sensitive information, such as addresses or passport numbers. The Defence was subsequently informed about the uploaded documents by the Prosecution. The witness statements of Witnesses Jovan Mirković, Smiljana Mirković, and Dušan Torbica, after provisionally being admitted into evidence under seal, had been uploaded together with the respective Rule 92 *bis* attestations. However, in its Third Decision on Rule 92 *bis* Witnesses of 3 November 2008, the Chamber ordered that the attestations are to remain under seal. Accordingly, the Prosecution has now uploaded the respective statements without the attestations.
3. The Chamber considers that since the substantive evidentiary record would not change when admitting redacted versions of already admitted exhibits, it is not

necessary to invite further submissions from the Defence. Furthermore, none of the Defence teams have raised objections in relation to the uploaded documents.

4. The Chamber further notes that for some documents the Prosecution neither has requested protective measures nor considered that potentially sensitive information should be redacted and accordingly finds it appropriate to, if not done already on a previous occasion, lift the confidential status of those documents.<sup>3</sup>

5. Some documents<sup>4</sup> whose status was lifted by the Chamber on 24 February 2009<sup>5</sup> need, due to the Prosecution's sought redactions of potentially sensitive information, to be put under seal again. At the same time, the Chamber notes that the documents admitted in its Third Decision on Rule 92 *bis* Witnesses of 3 November 2008 were admitted as public documents whereas they should have been admitted at least provisionally under seal. These documents should therefore also be put under seal.<sup>6</sup> Finally, the Chamber notes missing BCS versions of Witness Milica Karanović's statements (65 *ter* number 6820a and P2510) and a missing English translation of Witness Jovan Popović's statement under 65 *ter* number 6822a.

#### Disposition

6. For the foregoing reasons and in line with the Chamber's decisions referred to in footnote 1, the Chamber

**ADMITS** into evidence:

(a) The redacted Rule 92 *quater* package for Witness Petar Čolović (65 *ter* # 5207a);

(b) The redacted Rule 92 *quater* package for Witness Jovan Grubor (65 *ter* # 5209a);

**LIFTS** the confidential status of exhibits P2506, P2511, P2513, P2514, and P2515;


