**TRIAL CHAMBER I** ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**NOTING** the oral order of the Trial Chamber of 12 November 2009 ("Oral Order") setting the Pre-Defence Conference on 25 January 2010 and the start of the Defence case on 26 January 2010;<sup>1</sup>

**NOTING**, however, the "Decision on Prosecution Motion to Add Garry Selsky as a 92*bis* Witness", filed publicly on 21 January 2010, wherein the Trial Chamber granted in part the declaration of Garry Selsky of 25 October 2007 into evidence pursuant to Rule 92 *bis* of the Rules of Procedure and Evidence ("Rules") and ordered Garry Selsky to appear for cross-examination by the Defence:<sup>2</sup>

#### **PURSUANT TO** Rule 54 of the Rules,

Hereby AMENDS the Oral Order and ORDERS the following:

- a) The Prosecution will be resuming on 25 January 2010 with the testimony of Garry Selsky; and
- b) defers its decision on the scheduling of the Pre-Defence Conference and the commencement of the Defence case until the Prosecution has officially closed its case.
