TRIAL CHAMBER I (“Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

RECALLING the Decision on Prosecution’s Motion to Reopen Its Case, filed confidentially on 21 April 2010, in which the Chamber granted the Prosecution’s motion to reopen its case to present new evidence;

NOTING that on 10 May 2010 the Chamber instructed the parties through an informal communication to discuss suitable dates for hearing the new evidence and to provide suggestions or agreed solutions to the Chamber by 12 May 2010;


NOTING that on 12 May 2010 the Prosecution informed the Chamber, through an *inter partes* informal communication, of the positions of the parties with regard to scheduling and indicated that 2 June 2010 would be a suitable time to begin hearing the new evidence;

PURSUANT to Rule 54 and Rule 65 *ter* of the Tribunal’s Rules of Procedure and Evidence (“Rules”);

HEREBY ORDERS that hearings will resume on Wednesday 2 June 2010, at 2.15 p.m. in Courtroom III of the Tribunal; and

INSTRUCTS the Prosecution to file an addendum to its witness list pursuant to Rule 65 *ter* of the Rules within one week of the filing of this decision.
