## **ORDER REASSIGNING MOTION**

## Amicus Curiae Prosecutor

## The Accused

Mr. Vojislav Šešelj

**I, PATRICK ROBINSON**, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal");

**NOTING** the "Motion By Professor Vojislav Šešelj for the Disqualification of Judges O-Gon Kwon and Kevin Parker", filed confidentially on 27 April 2010 ("Motion for Disqualification");<sup>1</sup>

**NOTING** that in the Motion for Disqualification Vojislav Šešelj requests that the President of the International Tribunal: (1) "issue a decision on the merits of this application and hear the opinion of the judges whose disqualification is being sought pursuant to Rule 15(B)(i)" of the Rules of Procedure and Evidence ("Rules"), (2) appoint, pursuant to Rule 15(B)(i) of the Rules, a panel of three Judges to consider the Motion for Disqualification, and (3) pursuant to Rules 15 and 19 of the Rules "assign another two judges to the Trial Chamber that will sit in Case IT-03-67.R77.3";<sup>2</sup>

**NOTING** that pursuant to Rule 15(B)(i) of the Rules where a party has applied to the Presiding Judge of a Chamber for the disqualification and withdrawal of a Judge of that Chamber, "[t]he Presiding Judge shall confer with the Judge in question and report to the President";

**NOTING** that Judge O-Gon Kwon, Vice-President of the International Tribunal, is also the Presiding Judge in the present matter;

**NOTING** the memorandum issued by Judge Burton Hall dated 6 May 2010 ("Memorandum") in which he states that "[i]n the instant case the Accused is seeking the disqualification of the Presiding Judge himself" and that consequently "the Presiding Judge is not in a position to report to the President pursuant to Rule 15(B)(i)";<sup>3</sup>

**NOTING** that the Memorandum further states that "[a]s the one Judge on the Panel whose disqualification the Accused is not seeking" Judge Burton Hall refers the Motion for Disqualification to the President of the International Tribunal "for further proceedings pursuant to Rule 15";<sup>4</sup>

**NOTING** that at the time the Motion for Disqualification was filed I was absent from the International Tribunal;

**NOTING** that pursuant to Rule 21 of the Rules the Vice-President shall exercise the functions of the President in case of the latter's absence or inability to act;

**NOTING** that on 7 May 2010 Judge O-Gon Kwon issued an order assigning the Motion for Disqualification to Judge Mehmet Güney pursuant to Rule 15(A) and Rule 22 of the Rules;<sup>5</sup>

**NOTING** that in the Order Assigning Motion Judge O-Gon Kwon reasoned that his status as one of the two Judges impugned in the Motion for Disqualification gave rise to a conflict of interest warranting his withdrawal from considering the Motion for Disqualification pursuant to Rule 15(A) of the Rules;<sup>6</sup>

**CONSIDERING** that the Motion for Disqualification remains to be resolved;

**HEREBY REASSIGN** myself, with immediate effect, to consider the Motion for Disqualification in place of Judge Mehmet Güney.
