I, **MEHMET GÜNEY**, a Judge of the International Criminal Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**NOTING** that the Registry has found that the parties have been tendering unofficial and unrevised versions of transcripts as public or confidential exhibits in the case *Prosecutor v. Milan Lukić and Sredoje Lukić*, Case no. IT-98-32/1-T (“*Lukić and Lukić case*”);<sup>1</sup>


**CONSIDERING** that it is not in the interests of justice that exhibits contain unofficial and unrevised versions of transcripts which may potentially include confidential information and would not reflect the correct and complete record of prior proceedings;

**PURSUANT TO** Rule 54 of the Rules of Procedure and Evidence;

**HEREBY ORDER** the parties to replace, without undue delay and in consultation with the Registry, the unofficial and unrevised versions of transcripts which were admitted as public or confidential exhibits throughout the trial proceedings in the *Lukić and Lukić case* with the official and revised versions of those transcripts.
