THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the

Territory of the former Yugoslavia since 1991 ("Tribunal");

BEING SEISED OF the Accused's "Motion for Binding Order: Government of Bosnia", filed

on 31 August 2009 ("Motion"), requesting under Article 29 of the Statute of the Tribunal

("Statute") and Rule 54 bis of the Rules of Procedure and Evidence of the Tribunal ("Rules")

that the Chamber order Bosnia and Herzegovina ("BiH") to provide him with a number of

documents he claims to be relevant to his case;¹

NOTING all the filings in relation to the Motion which have been submitted by the Accused

and BiH;

NOTING the "Order Scheduling a Hearing Pursuant to Rule 54 bis (Bosnia and Herzegovina)"

issued by the Chamber on 7 September 2010 ("First Order"), scheduling a Rule 54 bis hearing in

relation to the Motion ("Hearing") and inviting BiH to file its notice of objection pursuant to

Rule 54 bis (F), if any, not less than five days before the Hearing;

NOTING the "Order to Bosnia and Herzegovina in Preparation for the Hearing Pursuant to

Rule 54 bis" issued by the Chamber on 6 October 2010 ("Second Order"), inviting BiH to file its

notice of objection, if any, by Monday, 11 October 2010, at the latest, together with the name

and the capacity of the designated BiH official(s) who will attend the Hearing;

NOTING that, on 12 October 2010, BiH informed the Chamber that the Hearing would be

attended by its Ambassador to The Netherlands, H.E. Mrs. Miranda Sidran Kamišalić;²

CONSIDERING that, in both the First and the Second Order, the Trial Chamber indicated that

a detailed schedule of the order of presentation of arguments would be issued following the

filing of notice of objection, if any;³

CONSIDERING the responsibility of BiH to co-operate with the Tribunal pursuant to Article

29 of the Statute;

PURSUANT TO Article 29 of the Statute and Rules 54 and 54 bis (D) of the Rules;
