TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

PROPRIO MOTU,

NOTING the "Decision on Prosecution's Motion for Admission of Evidence Relating to Mladić Notebooks with a Separate Opinion from Presiding Judge Antonetti Attached", filed publicly on 22 October 2010 ("Decision of 22 October 2010"),

CONSIDERING that the Chamber has been informed by the Registry that the expert considered most capable of meeting the conditions required by the Decision of 22 October 2010 required more time to fulfil his assigned task properly,¹

CONSIDERING that the Chamber takes note of the difficulty of locating an expert who meets all of the required conditions in the Decision of 22 October 2010, as well as of the need to grant the expert more time to ensure the quality of his report,

FOR THE FOREGOING REASONS,

PURSUANT TO Rule 54 of the Rules of Procedure and Evidence,

ORDERS that the time-limit for filing the expert report established by the Decision of 22 October 2010 be extended to 60 (sixty) days, to run from the day the designated expert gains access to the documents that he needs to carry out his task.
