#### DECISION ON PROSECUTION SUBMISSION CONCERNING P1951 AND MFI P1952

**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**BEING SEISED OF** the "Prosecution Submission Concerning Exhibit P1951 and MFI P1952", filed on 1 December 2010 ("Submission") in which the Office of the Prosecutor ("Prosecution") requests the admission into evidence of a video clip previously marked for identification as P1952;<sup>1</sup>

**NOTING** that, on 29 November 2010, the Chamber marked P1952 for identification, pending clarification of its date from the Prosecution after the witness to whom it was shown (KDZ310) could not confirm its date:<sup>2</sup>

**NOTING** that, in the Submission, the Prosecution concludes that the video clip was recorded on 30 September 1992, based on reviewing the extended video from which it was excerpted, as well as considering the relevant testimony of KDZ310;<sup>3</sup>

**NOTING** that, on 9 December 2010, by way of email to the parties, the Chamber requested a copy of the complete video, as well as any available English transcript;

**NOTING** that on 10 December 2010, the Prosecution filed the "Prosecution Notification Concerning Exhibit MFI P1952 with Appendix A", providing the Chamber with a copy of the complete video from which MFI P1952 was extracted, as well as a corresponding English transcript;<sup>4</sup>

**CONSIDERING** that the Trial Chamber has reviewed the complete video and the corresponding English transcript and is satisfied that it refers to the "last day of September", which, in conjunction with the testimony provided by KDZ310, confirms the date of the video clip marked for identification as P1952 as 30 September 1992;

**NOTING** that the Trial Chamber has already admitted P1951 into evidence and that it need not further address the status of that exhibit in this decision;
