FOURTH ORDER ON CHART OF PROTECTIVE MEASURES FOR WITNESSES

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

NOTING its confidential "Decision on Protective Measures for Witnesses", issued on 24 July 2009, by which it created a chart including a comprehensive list of all the protective measures which are in force for witnesses appearing on the Office of the Prosecutor ("Prosecution")'s Rule 65 *ter* witness list ("Chart");

NOTING also its "Order on Chart of Protective Measures for Witnesses", issued on 14 August 2009, its "Second Order on Chart of Protective Measures for Witnesses", issued on 24 August 2010, and its "Third Order on Chart of Protective Measures for Witnesses", issued on 23 November 2010, by which it amended the Chart, after having received parties' submissions in relation thereto;

HAVING carefully reviewed the submissions filed by the parties since 23 November 2010 in relation to protective measures for witnesses being brought by the Prosecution in this case, as well as the Chamber's own decisions on the matter, and **HAVING** revised the amended Chart as it has deemed appropriate;

NOTING that the Prosecution only informed the Chamber in July and August 2011 that other Trial Chambers had, in February 2009 and December 2010 respectively, varied the protective measures of two of the witnesses listed in the attached annexes¹;

PURSUANT TO Articles 20, 21, and 22 of the Tribunal's Statute, and Rules 54, 69, 70, 75, and 79 of the Tribunal's Rules of Procedure and Evidence:

HEREBY ORDERS that the revised Chart, as set out in confidential Annex A and confidential and *ex parte* the Accused Annex B to this Order, and as further revised in light of any later procedure and/or decisions on protective measures, shall remain the primary record of protective measures in force for all witnesses in the case;

INSTRUCTS the parties, should they wish to make any submissions related to the accuracy of the revised Chart, to do so by no later than 30 September 2011; and

INSTRUCTS the Prosecution to immediately inform the Chamber and the Accused when there is a variation of the protective measures in place for any of the witnesses in the Chart.
