THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the

Territory of the Former Yugoslavia since 1991 ("Tribunal"),

NOTING that On 30 November 2011, Milan Tupajić (the "Accused") was charged with

contempt of the Tribunal pursuant to Rule 77(A) of the Tribunal's Rules of Procedure and

Evidence ("Rules") for knowingly and wilfully interfering with the administration of justice by

refusing to comply with two subpoenas issued by the Chamber which ordered him to appear and

testify before the Chamber in the case of Prosecutor v. Radovan Karadžić ("Karadžić Case");1

**NOTING** the initial appearance of the Accused on 16 December 2011 ("Initial Appearance"),

during which the Accused maintained that he would not testify in the Karadžić Case and

pleaded not guilty to the contempt charge;<sup>2</sup>

NOTING that on 21 December 2011 the Chamber granted the Accused's motion for provisional

release and ordered in its "Decision on Motion for Provisional Release" ("Provisional Release

Decision") that he be released as soon as practicable, on conditions, *inter alia*, that he return to

the Tribunal at such time and on such date as the Chamber may order;<sup>3</sup>

CONSIDERING that it is in the interests of justice, given the nature of the charge and the

Accused's indication at the Initial Appearance that he is prepared for the proceedings, that the

trial of the Accused be held as soon as practicable;<sup>4</sup>

PURSUANT TO Articles 20 and 29 of the Statute of the Tribunal and Rules 54, 65, and 73 bis

of the Rules;

**ORDERS** that:

(A) A pre-trial conference in the Accused's case shall be held on Friday 20 January 2012 at

9 a.m. in a courtroom to be designated by the Registry;

(B) The trial shall commence on Friday 20 January 2012 following the pre-trial conference;

ORDERS the Accused to return to the United Nations Detention Unit by Wednesday

18 January 2012, thereby terminating his provisional release;

REQUESTS the Government of Bosnia and Herzegovina to ensure that the Accused is

transported from his usual place of residence in Bosnia and Herzegovina to Schiphol airport and

delivered into the custody of the designated officers of the Government of the Kingdom of the

Netherlands in accordance with the Provisional Release Decision;<sup>5</sup>

**REQUESTS** the Government of the Kingdom of the Netherlands to ensure that the Accused is

transported, under guard, from Schiphol Airport to the custody of the United Nations Detention

Unit; and

ORDERS the Registry to make all necessary arrangements, including liaising with the

Governments of the Kingdom of the Netherlands and Bosnia and Herzegovina, to enable the

Accused to return by Wednesday 18 January 2012.
