THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

NOTING the "Final Trial Brief", with annexes, filed confidentially by the Prosecution on 11 June 2012;

**NOTING** the "Defence Final Trial Brief", filed confidentially by the Accused, Zdravko Tolimir, in BCS on 11 June 2012, with an English translation filed confidentially on 16 July 2012;

CONSIDERING that pursuant to Article 20(4) of the Statute of the Tribunal ("Statute") and Rule 78 of the Rules of Procedure and Evidence of the Tribunal ("Rules"), all proceedings before a Trial Chamber, other than deliberations, shall be held in public, unless otherwise provided, and it is therefore appropriate for final trial briefs to be available to the public to the fullest extent possible;

CONSIDERING, further, the obligation of the parties to assist the Tribunal in protecting the identities of witnesses subject to protective measures and the duty to take particular care not to disclose information that could lead to the identification of protected witnesses, especially when taking into account the entirety of the Tribunal's publicly available proceedings;

PURSUANT to Articles 20(4), 21, and 22 of the Statute and Rules 54, 78, and 86(B) of the Rules,

**HEREBY ORDERS** the parties to file public redacted versions of their respective final trial briefs, including the annexes where applicable, by 1 October 2012, in full respect of the spirit of the Statute and preserving all protective orders issued by this Tribunal.
