I, CARMEL AGIUS, Acting President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

NOTING that on 19 September 2012, Trial Chamber III of the Tribunal denied in part Radovan Karadžić’s (“Karadžić”) request for additional time for the presentation of his case;¹

NOTING the “Appeal from Decision on Duration of Defence Case”, filed by Karadžić on 12 October 2012;

CONSIDERING Articles 12 and 14 of the Statute of the Tribunal and Rule 73 of the Rules of Procedure and Evidence of the Tribunal (“Rules”);

CONSIDERING the composition of the Appeals Chamber of the Tribunal as set out in document IT/263/Rev.3, issued on 5 July 2012;

NOTING that President Theodor Meron is currently absent from the Tribunal and that, pursuant to Rule 21 of the Rules, the Vice-President shall exercise the functions of the President in case of the latter’s absence or inability to act;

HEREBY ORDER that the Bench in *Prosecutor v. Radovan Karadžić*, Case No. IT-95-5/18-AR73.10, shall be composed as follows:


