5109 22:33 A I cannot tell you with certainty. I have absolutely no
5209 22:33 orientation in time, and I cannot say things that I don't know.
5309 22:33 Q Did your husband or any other relative talk to you about how the

5509 22:33 A I don't remember. I think I was still in Novi Sad, and I saw on
5609 22:33 TV that the army had entered Erdut. I think that's how it was.




