NOTING the Judgement rendered in the case of *Prosecutor v. Zdravko Tolimir*, Case No. IT-05-88/2-T, by Trial Chamber II on 12 December 2012 ("Trial Judgement");²

NOTING that Zdravko Tolimir ("Tolimir") filed a notice of appeal on 11 March 2013;³

CONSIDERING that, pursuant to Rule 65 bis(B) of the Rules of Procedure and Evidence of the Tribunal ("Rules"), a status conference in a given case shall be convened within one hundred and twenty days of the filing of a notice of appeal, to allow any person in custody pending the appeal the opportunity to raise issues in relation thereto, including the mental and physical condition of that person;

NOTING that Tolimir is currently in custody at the United Nations Detention Unit in The Hague pending the resolution of his appeal against the Trial Judgement;

PURSUANT to Rule 65 *bis*(B) of the Rules;

HEREBY ORDER that a status conference shall be held before me on Friday, 5 July 2013 at 11:00 a.m. in Courtroom II.
