CORRIGENDUM TO PUBLIC AND REDACTED VERSION OF THE 27 MARCH 2013 DECISION OF PRESIDENT ON EARLY RELEASE OF RADOMIR KOVAČ

I, THEODOR MERON, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**NOTING** the "Public and Redacted Version of the 27 March 2013 Decision of President on Early Release of Radomir Kovač", issued on 3 July 2013 ("Decision");

**CONSIDERING** that the Decision erroneously states in paragraphs 36 and 37 that Radomir Kovač shall be released on 31 May 2013;

#### **ORDER** that the text:

"For the foregoing reasons and pursuant to Article 28 of the Statute, Rules 124 and 125 of the Rules, paragraph 8 of the Practice Direction, and Article 8(2) of the Enforcement Agreement, Radomir Kovač is hereby **GRANTED** early release, effective 31 May 2013."

and

"The Registrar is hereby **DIRECTED** to inform the Norwegian authorities of this decision as soon as practicable, as prescribed in paragraph 11 of the Practice Direction. Moreover, the Registrar is **DIRECTED** to request the Norwegian authorities to submit a report on or before 31 May 2013 with respect to Kovač's conduct during this period, if any change has occurred in respect thereto."<sup>2</sup>

shall be replaced by:

"For the foregoing reasons and pursuant to Article 28 of the Statute, Rules 124 and 125 of the Rules, paragraph 8 of the Practice Direction, and Article 8(2) of the Enforcement Agreement, Radomir Kovač is hereby **GRANTED** early release, effective 30 June 2013."

and

"The Registrar is hereby **DIRECTED** to inform the Norwegian authorities of this decision as soon as practicable, as prescribed in paragraph 11 of the Practice Direction. Moreover, the Registrar is **DIRECTED** to request the Norwegian authorities to submit a report on or before 30 June 2013 with respect to Kovač's conduct during this period, if any change has occurred in respect thereto."
