Case No. IT-03-67-T 13 November 2013 TRIAL CHAMBER III of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Chamber" and "Tribunal" respectively),

PROPRIO MOTU,

NOTING the close of hearings declared by Judge Antonetti, Presiding Judge of the Trial Chamber, on 20 March 2012, following the closing arguments from the Office of the Prosecutor and Vojislav Šešelj ("Prosecution" and "Accused", respectively), 1

NOTING the Scheduling Order issued by the Trial Chamber on 12 April 2013, in which it ordered that the judgement be pronounced on Wednesday, 30 October 2013,²

NOTING the Decision of 28 August 2013 rendered by a panel of three Judges ("Panel"), in which it found by majority, Judge Liu dissenting, that there exists an unacceptable appearance of bias on the part of Judge Harhoff and upheld the motion of the Accused to disqualify him from the present case,³

NOTING the order to rescind the scheduling order of 12 April 2013, issued by the Presiding Judge of the Trial Chamber on 17 September 2013,⁴

NOTING the decision of 7 October 2013 issued by the Panel, in which it denies by majority, Judge Liu dissenting, (1) the Prosecution's motion seeking reconsideration of the Decision of 28 August 2013, (2) the joint motion filed by Counsel for Mićo Stanišić and Stojan Župljanin seeking leave to make submissions on the aforementioned Prosecution motion, and (3) the request for clarification filed by Judge Antonetti and Judge Lattanzi,⁵

INVITES the Accused and the Prosecution to make their respective submissions on

the continuation of the proceedings within 14 days of receipt of the BCS translation of

this decision by the Accused.
