Mr. Radovan Karadžić Mr. Richard Harvey **THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

CONSIDERING the "Decision on Accused's Motion to Subpoena Ratko Mladić", issued on 11 December 2013 ("Decision"), in which the Chamber granted the Accused's motion filed on 18 April 2013, requesting that a subpoena be issued directing Ratko Mladić to appear before the Chamber to give oral testimony;¹

PURSUANT TO Rule 54 of the Tribunal's Rules of Procedure and Evidence ("Rules");

HEREBY ORDERS RATKO MLADIĆ:

TO APPEAR to testify before the Chamber in the case of *Prosecutor v. Karadžić* at the seat of the Tribunal at Churchillplein 1, 2517 JW, The Hague, The Netherlands on a date which will be communicated to him by the Registrar of the Tribunal, or to show good cause why this subpoena cannot be complied with. The date of Mr. Mladić's testimony is subject to change, and this subpoena remains in force notwithstanding any such change. Mr. Mladić will be notified of any change of date of, or location for, his testimony through the Registrar of the Tribunal.

FURTHER INFORMS RATKO MLADIĆ that all necessary measures will be taken by the Victim and Witness Section of the Tribunal for his travel and appearance, and that all necessary costs incurred by virtue of his testimony shall be borne by the Tribunal. Representatives of the Tribunal have been directed to take whatever steps are reasonably necessary to ensure service of this subpoena and his appearance at trial.
