ORDERS that the following blanked text be omitted from the public transcript of this hearing and be edited from the public broadcast of this hearing dated 01 October 2014.



ORDERS that the following blanked text be omitted from the public transcript of this hearing and be edited from the public broadcast of this hearing dated 2 October 2014.

 15:13:37 any reprisals taken against someone who was not opening fire and there is  
 15:13:43 no proof about deliberate and intentional conscious targeting of civilian  
 15:13:52 targets, and Karadžić did not direct terror as in paragraph 622 and as  
 15:14:00 can be seen from evidence about humanitarian proof.  
 15:14:17 Our paragraphs 1324 and 1325 and 2984 and 2988 explain this  
 15:14:17 question. The Prosecutor's invoking some secondary sources of people who  
 15:14:21 are not in the know about how allegedly Karadžić had said something or  
 15:14:25 how they had understood something that Karadžić had said is of no  
 15:14:32 relevance. It cannot be of any importance in respect of the documents  
 15:14:37 having regard to the documents I sent to the army, I was the only  
 15:14:42 supreme commander who was commanding the army and my conflicts with the  
 15:14:46 army were not because of some crimes which they committed or mine own; it  
 15:14:53 was actually a fight for them to let through humanitarian relief. Here  
 15:14:58 you say that Karadžić managed -- managed the crisis by managing  
 15:15:03 humanitarian relief. I interfered with humanitarian relief only when we  
 15:15:07 requested by the representatives of the international community and  
 15:15:13 Ambassador Ogata thanked me personally. I went to Bratunac many times to  
 15:15:19 convince not the army the troops, but the people to let humanitarian
