**THE APPEALS CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**BEING SEISED** of the appeal lodged by Zdravko Tolimir<sup>1</sup> against the judgement rendered in this case by Trial Chamber II of the Tribunal on 12 December 2012 (“Trial Judgement”);<sup>2</sup>

**NOTING** that Rule 114 of the Rules of Procedure and Evidence of the Tribunal provides that “[a]fter the expiry of the time-limits for filing the briefs provided for in Rules 111, 112 and 113, the Appeals Chamber shall set the date for the hearing and the Registrar shall notify the parties”;

**CONSIDERING** that the filing of the briefs in these appeal proceedings is complete;<sup>3</sup>

**HEREBY ORDERS** that the appeal hearing in the present case shall take place on **Wednesday, 12 November 2014** in a courtroom to be announced by the Registry of the Tribunal and **INFORMS** the parties that the timetable for the appeal hearing shall be as follows, subject to adjustments as appropriate:


